The Company (we, us, our) collects and processes personal data relating to its Customers (and their Customers) to manage the relationship and ensure we can provide the high level of service expected of us. We are committed to being transparent about how we collect and use that data and to meeting our data protection obligations.

## What information does the Company collect?

We collect and process a range of information about you. This includes:

## **Direct Customers: -**

- your name, address and contact details, including email address and telephone number;
- our contract with you and any subsequent variations to that contract;
- details of key contacts with names, email addresses and contact telephone numbers;
- details of your orders and arrangements to supply and/or fit our products;
- details of any remedial works of after sales work required;
- payment details or invoices;
- bank details to make or receive payments;
- details of our correspondence with you;
- details of credit reference searches where appropriate;
- accident records.

Indirect Customers, Customers of Our Customers: -

- customer name, address and contact details, including email address and telephone number;
- details of your orders and arrangements to supply and/or fit our products.

We may collect this information in a variety of ways. For example, data might be provided by you or our main contractor directly or collected through monitoring internal computer systems.

We may also obtain credit reference agency information.

We may also buy information about you or potential new customers generally from third parties including demographic information, marketing lists and publicly available information.

#### Why does the Company process personal data?

We need to process data to: -

- provide the product or service we have agreed to deliver and to ensure we are able to contact the necessary persons to meet this obligation;
- open credit accounts;
- respond to and defend against legal claims;
- to enable us to target specific communications to appropriate customers.

#### What do we do with it? What is the legal basis for this use?

We are careful to protect the data we collect and only use it for specific purposes: -

- We will collect, hold and process such data as is necessary to allow us to fulfil our contractual obligations both as customer and supplier;
- We will process such data when it is in our legitimate interests to do so, i.e. in the normal course of our trading relationship and when these interests are not overridden by your data protection rights;
- Communications for legitimate business interests and promotion of products which you may find of interest.

### Who do we share it with?

We do not share your data outside of the Group of companies apart from where we have your express permission i.e. credit reference agencies or if there is a necessity to do so to deliver our contractual obligations.

#### Where is it stored?

Data will be stored in a range of different places, including internal filing systems and in other IT systems/workflow software (including our email system).

All data is stored within the UK / EU.

#### How does the Company protect data?

Such data will be reviewed annually to ensure out of date or irrelevant data is removed/updated.

#### Your rights

As a data subject, you have a number of rights. You can:

- access and obtain a copy of your data on request;
- require us to change incorrect or incomplete data;
- require us to delete or stop processing your data, for example where the data is no longer necessary for the purposes of processing; and
- object to the processing of your data where we are relying on our legitimate interests as the legal ground for processing.
